



GILES WORSLEY ROME FELLOWSHIP 2023–4

THE GILES WORSLEY ROME FELLOWSHIP is a research award given for the study of architectural history.

It is open to architectural historians and architects whose research in the field of architectural or urban history would benefit from the opportunity to spend three months at the BSR experiencing the reality of buildings and spaces in and around Rome which are related directly, or indirectly, to their subject of study.

While the research carried out at the BSR may be part of a wider project, the intention is that it should be brought together and presented at the end of the Fellowship as a discrete piece of work.

As the Giles Worsley Rome Fellow, the successful candidate will have exceptional access to the extensive collections of the BSR Library and Archive. They will also form part of the community of artists and scholars resident at the BSR, and be able to benefit from, and contribute to, the intellectual and social exchange that has always been such an important aspect of the life of the BSR.

The Fellowship offers:

- board and accommodation in a study-bedroom
- a monthly research and travel grant
- duration: 3 months (late September–late December 2023).

Applicants must be:

of British or Commonwealth nationality, or have been working professionally or studying at postgraduate level for at least the last three years in the UK or Commonwealth (i.e. since March 2020).

The Fellowship is in memory of Giles Worsley, the distinguished architectural historian and critic, who died of cancer in 2006 at the age of 44. He was an enthusiastic visitor to Italy and a great believer in the importance of Italian architecture of all periods in understanding the development of Western architecture.

Selection criteria

Applications will be considered by a panel including an RIBA representative, British School at Rome representatives and at least one person appointed by Giles's family. Applications will also be reviewed by members of the BSR's Faculty of Architecture (see <https://bsr.ac.uk/about-us-governance/>).

Applications will be assessed using the following criteria:

1. the quality of the applicant's creative and/or academic output (judged on the application and references);
2. the inherent significance and interest of the project proposed;
3. the feasibility of the project being undertaken in three months, and being an end in itself, rather than a means to an end;
4. the suitability of the project for the BSR, bearing in mind its location, resources and access to resources;
5. the potential for the Fellowship to impact on the applicant's professional development and on her/his contribution to architecture and/or architectural history;
6. the suitability of the applicant to contribute to the academic community of the BSR.

The panel's decision is final; and feedback cannot be given on unsuccessful applications.

The award was an unforgettable experience that gave me the opportunity to challenge my creative output. My time in Rome, exploring both scholarly and artistic processes, was really the stepping stone for me to test what this meant to me more specifically.

Successful applicants must:

- live at the BSR throughout the period of the award
- agree to abide by the BSR's Code of Conduct (<https://bsr.ac.uk/wp-content/uploads/2022/02/BSR-Code-of-Conduct-1.pdf>) and any other relevant policies and codes in place at the time of appointment and tenure
- be prepared to learn some Italian before going to Rome
- take out medical insurance for the duration of their tenure
- submit a report on their tenure.
