



## ROME SCHOLARSHIP IN ARCHITECTURE 2023–4

THE ROME SCHOLARSHIP IN ARCHITECTURE is awarded to a recently qualified architect (post Part II) who has shown exceptional promise in their student work or their early professional career, or both.

The successful candidate will spend three months at the BSR undertaking their own, self-directed programme of research. This research — related to the city of Rome or, if appropriate, elsewhere in Italy — may take the form of an architectural project, a theoretical study or an historical investigation, or indeed a combination of all three.

The successful candidate will have exceptional access to the extensive collections of the BSR Library and Archive. They will also form part of the community of artists and scholars resident at the BSR, and be able to benefit from, and contribute to, the intellectual and social exchange that has always been such an important aspect of the life of the BSR.

This year, the Scholarship is being generously supported by the following practices: Stiff Trevillion, Sheppard Robson, Reiach and Hall, Eric Parry Architects, Maccreeanor Lavington, Jeremy Blake, Arup, AHMM, and Adam Architecture.

### The Scholarship offers:

- board and accommodation in a study-bedroom
- monthly research and travel grant
- duration: 3 months (late September–late December 2023).

### Applicants must be:

of British or Commonwealth nationality, or have been working professionally or studying at postgraduate level for at least the last three years in the UK or Commonwealth (i.e. since March 2020)

## Selection criteria

The selection panel will be members of the BSR's Faculty of Architecture — Bob Allies, Tim Bell, Denise Bennetts, Marco Iuliano, Niall McLaughlin and MaryAnne Stevens.

In making an appointment to the Scholarship the panel will assess all applications using the following set of criteria:

1. the quality of the applicant's creative output
2. the intellectual coherence of the proposal
3. the viability of the proposal as a project to be carried out with support from the BSR
4. the potential of the Scholarship to impact on the applicant's professional, creative and intellectual development.

In addition to these basic selection criteria, the selectors will attempt to ensure that the needs and interests of the successful applicant are compatible with the facilities available at the BSR and the interests of its community. Credit will be given to those who are no longer in full- or part-time education at the time of application. Candidates will be expected to have some knowledge of Italian or be willing to learn. Those who acknowledge the importance of communicating with Italians will derive the most benefit from being at the BSR.

The selection panel's decisions are final. Feedback cannot be given on unsuccessful applications.

Successful applicants must:

- live at the BSR throughout the period of the award
